### Investment Objective

The investment objective of the Fund is to achieve long term capital growth. The Fund will invest, under normal market conditions, primarily in global equity securities of companies that are relevant to the investment theme of disruptive innovation - defined as the introduction of a technologically enabled new product or service that potentially changes the way the world works. The Investment Manager believes that companies relevant to this theme are those that rely on or benefit from the development of new products or services, technological improvements and advancements in scientific research relating to: **Genomic Revolution Companies** - the study of genes and their functions and related techniques. **Industrial Innovation Companies** - in energy, automation and manufacturing. **Web x.0 Companies** - the increased use of shared technology, infrastructure and services. **FinTech Innovation Companies** - technologies that make financial services more efficient. The Sub-Fund is classified as article 6 and analyses sustainability risk as part of its risk management process to enhance its long-term risk adjusted return but does not promote specific environment, social or sustainability characteristics within the meaning of the SFD Regulation.

### Performance Information

### Monthly Fund Commentary

Top contributors include Coinbase, Robinhood, Block, Exact Sciences and Roku. Coinbase was a contributor, benefiting from continued strength across crypto markets and Bitcoin broke through \$70,000 in March, setting a new all-time high. Robinhood benefited from a positive research report and was supported by continued strength across cryptocurrencies. In addition, Robinhood unveiled a new credit card offering competitive with other premium cards in the US. Block also benefited from continued strength across crypto markets. Exact Sciences was a significant contributor this month, announcing the launch of Riskguard hereditary cancer test in the US. Exact Sciences also published the Cologuard Plus test, demonstrating that it outperformed another commercially available test for detecting cancer or precancer. Roku also contributed and Jeff Blackburn, board member and former Senior Vice President of Global Media and Entertainment at Amazon, conducted an open market purchase of over \$500K of Roku shares, the first insider buy since the IPO. Detractors include Tesla, CRISPR Therapeutics, Recursion Pharmaceuticals, 10X Genomics and Ginkgo Bioworks. Tesla detracted amid Wall Street concerns over a slowdown in global EV adoption and on the back of several pieces of company specific news. CRISPR Therapeutics detracted on no company specific news. Recursion Pharmaceuticals detracted after reporting fourth-quarter results in February, including a decline in revenues on a year-over-year basis, which management attributed to lumpiness in milestone payments. 10X Genomics detracted despite beginning commercial shipments of Chromium GEM-X products, expanding the Xenium menu with multi-modal cell segmentation kit and immuno-oncology gene panel, and commercially launching Visium HD spatial gene expression assay. Ginkgo Bioworks detracted despite benefitting from multiple strategic partnerships formed during this period. They are collaborating with Imagindairy to develop and produce animal-free non-whey dairy proteins. Additionally, Ginkgo Bioworks formed a partnership with AQUA Cultured Foods to optimise alternative seafood production. And they were awarded DARPA funding to produce proteins for controlling ice in extreme cold weather environments.

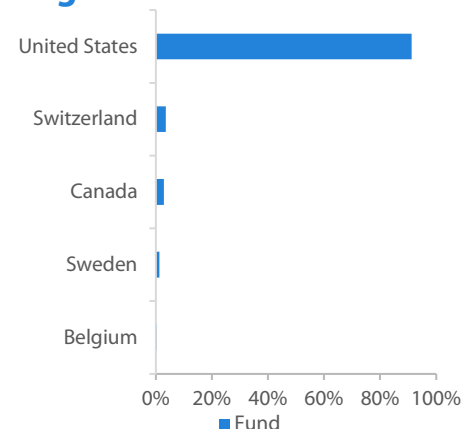

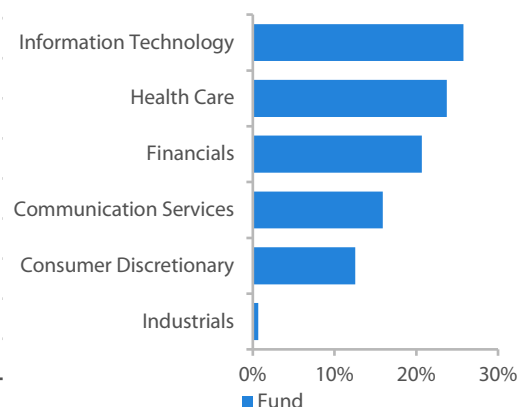
